We are reaching back out to you to share an update on the TreeHouse Foods, Inc. frozen waffle recall that we informed you about on Friday, October 18, 2024.

Kodiak learned today during an on-site visit to TreeHouse Food's Brantford, Canada facility that TreeHouse Foods will be expanding the voluntary frozen waffle recall to include all products made at TreeHouse Foods' Brantford, Canada facility, due to the potential to be contaminated with *Listeria monocytogenes*. TreeHouse Foods will be updating its press release in cooperation with the U.S. Food and Drug Administration (FDA) and the Canadian Food Inspection Agency (CFIA).

The recall now includes the following Kodiak products:
